


# Changes in Enrollment, May 2017–May 2019

- Total Medicaid and CHIP enrollment has declined by approximately 1.9 million (2.5 percent)
  - Almost 930,000 children (2.6 percent)
  - About 787,000 adults (2.2 percent)
- Variation across states
  - 15 states reported enrollment increases
  - 35 states and the District of Columbia reported enrollment declines

**Notes:** Child enrollment is not reported in Arizona, the District of Columbia, and Tennessee. Due to a methodological change in Texas, baseline data are reported from June 2017.

## **Changes in Insurance**

- Percentage of uninsured individuals increased nationally and in eight states between 2017 and 2018
- National data indicate:
  - percentage of individuals with Medicaid declined, with no significant change in percentage with private coverage
  - percentage of children with coverage and with Medicaid declined, with no significant change in percentage of children with private coverage

## **Changes in Employment**

- Between May 2017 and May 2019, all but seven states experienced an increase in the number of employed individuals
- Gains in employment do not necessarily align with declines in Medicaid and CHIP enrollment

- Federal policy changes

- Project examining the remaining risk points for states and individuals in the enrollment and renewal process
- Review of Payment Error Rate Measurement (PERM) findings at December meeting




